Please let us know if you are planning to attend. It is imperative that you pre-register for all classes you want to attend. Failure to do so may result in the class being cancelled for low enrollment, failure of the instructor to bring enough materials for all students who arrive, or refusal to allow you to attend the class in situations where enrollment is limited. **If you are signed up for a class, please notify the Academy within 24 hours before the class that you will not be unable to attend.** This may give someone else an opportunity to take your place. All training will be held at the LSO Training Academy at no charge, unless otherwise specified at: 801 Main Street Lubbock, Texas 79401.

### Training Mandates & Certificates

There are two 24-month periods in the current training cycle which ends on August 31, 2027. The first 24-month period, or unit, begins on 09/01/2023 and ends on 08/31/2025. The second 24-month period, or unit, begins on 09/01/2025 and ends on 08/31/2027, which is also the conclusion date of the 48-month training cycle.

**All Licensed Peace Officers with or without an Intermediate (or higher) Proficiency Certification (includes County Sheriffs and Deputy Constables):**

**Current 2-year Training Unit:** (09/01/23 - 08/31/25): Minimum 40 hours of training to include:

- Legislative Update course (#3188)
- 16 hours of ALERRT training\*
- Finding Wellness – Building a Healthier Life (course #4202) in-person or on MyTCOLE 3.0.

- Trauma-Informed Approach to Sexual Assault Investigations (MyTCOLE 3.0 online course #470 or in-person training course #4070), if not completed in the 9/1/21-8/31/23 unit. An equivalent to this course will be #3264 – Special Investigator Certification

\*The passage of Senate Bill 1852 requires **all peace officers to attend ALERRT Level 1 training at least once** prior to 8/31/2027. Courses which will satisfy this requirement include #3311, #3313, and train-the-trainer #3315. This new law also requires that every peace officer complete 16 hours of ALERRT training every two-year unit going forward.

Peace officers who have previously completed course #3311, #3313, or #3315 and have at least one of these courses documented on their TCOLE training record do not need to repeat ALERRT Level 1 training; however, they must take at least 16 hours of ALERRT training during this 2-year training unit before 8/31/2025. Courses which will satisfy the 16-hour requirement are included in the approved list below.

Peace officers who do NOT have course #3311, #3313, or #3315 documented on their TCOLE training record are encouraged to complete course #3311 during this current training unit prior to 8/31/2025 as their 16-hour continuing education requirement if at all possible. If not completed during this training unit, they MUST have completed #3311 prior to 8/31/2027 in accordance with Senate Bill 1852.

**What is the CSE-IT?** WestCoast Children's Clinic's Commercial Sexual Exploitation-Identification Tool (CSE-IT, pronounced "see it") is a validated screening tool that helps identify children who are commercially sexually exploited (CSE). The CSE-IT is appropriate for use by any provider serving youth, including child welfare workers, probation officers, mental health clinicians, and first responders. The CSE-IT is designed to improve early identification of children and

youth who are at high risk of experiencing or may be experiencing commercial sexual exploitation (CSEC) and human trafficking.

**Why is CSE-IT training important for law enforcement and criminal justice**

**personnel?** Law enforcement officers and criminal justice personnel often encounter vulnerable and at-risk children and youth when carrying out their duties. CSE-IT training will help equip law enforcement officers and criminal justice personnel with information they can use to more effectively identify children who may be experiencing commercial sexual exploitation.

Who should attend this training? Anyone who works in the criminal justice field, particularly those who work with children and youth.

**Who should attend this training?** Anyone who works in the criminal justice field, particularly those who work with children and youth.

**This CSE-IT Training will:**

- Enable law enforcement and criminal justice personnel to accurately identify indicators of child sexual exploitation, without relying solely on youth self-disclosure, alerting the need for investigation, and
- Provide a framework of language and understanding that will improve their communication with service providers and partners doing collaborative work in human trafficking prevention and identification.

**Attendees will receive instruction on:**

- How to use and score the CSE-IT screening tool.
- The importance of a victim-centered approach when dealing with victims of human trafficking.
- How victims of human trafficking are groomed by traffickers.
- How trauma and repeated trauma impacts the brain.
